#### **Backflow Preventers**


Backflow preventers sized from ½" – 2" have green handles on the shut-off valves. Model numbers are designated with the "XL" suffix, which can be seen etched on product bosses or in the castings. 900 series backflow preventers are designated with the "XL2" suffix as "975XL2" and "950XLT2". All leadfree backflow preventers have a white fiber tag with green text providing lead-free information.

# **Pressure Regulators**

Pressure Regulators sized from ½" - 3" have two lead-free designated tags: a metal lead-free product identification tag and a white fiber tag with green text providing lead-free information. Model numbers are designated with the "XL" suffix and it can be seen in the castings.

# **Thermostatic Mixing Valves**

Thermostatic Mixing Valves have green caps and are designated with the "XL" suffix, seen in the castings. In addition to what is shown, the description also applies to model numbers ZW1017XL and ZW3870XLT-4P.

# **Zurn PEX Fittings**

Zurn PEX "XL" brass barbed fittings sized from 3/8" – 2" are marked with the letter "G" indicating the product is listed to NSF Standard 61 Annex G for compliance with low-lead requirements. Part numbers are designated with a "G" or "GX" suffix. "XL Brass" is included in the product description.





## **Packaging**

Packaging utilizes green color as the lead-free designator. Brown boxes have white labels with green ink and Lead-Free clearly marked. Four-color packaging has a green gradient on the lower part of the box with lead-free clearly marked
