- Drain collected at a Z887 (6" x 20") with pre-attached 12" outlet to connect to 12" diameter pipe.
- Drain laid out in octagon shape with multiple pre-manufactured corners.
- Drain was set around a fountain in a courtyard at the patient drop-off and pickup area.
- Drain collects all flow from courtyard.
- Drain required to be both H20 Rated and ADA compliant.
- Drain installed in concrete and pavers dry set against trench drain pour.



Zurn Industries is a leader in innovative structural composite channel drain systems, with office and warehouse facilities in Falconer, New York.

Construction of a new Chesterfield County, VA, Sheetz gas station began in the summer of 2006. Chesterfield County officials require the installation of drainage systems in gas stations for potential fuel spillage. Zurn Flo-Thru provided 120 feet of Z886 six-inch wide Perma-Trench drainage systems with a H20 rate DI ADA top only 1-1/2" wide (9HS). This style of grate was specified by Sheetz to help reduce potential problems with customers crossing the drain. The six-inch outlet was tied to an Oil Water Separator. The Z886 modules were factory customized with a radius matching the Sheetz canopy. Perma-Trench catch basins installed both upstream and downstream allowed access for inspection and cleaning.

The contractor installed the Perma-Trench drainage system in one day utilizing a suspended-drain method. The first pour locked the drain in place, then covers were set in the channel and the final monolithic pour with the slab was made.


