





#### **Typical Installation**

Local codes shall govern installation requirements. Unless otherwise specified, the assembly shall be mounted in accordance with the manufacturers' instructions and the latest edition of the Uniform Plumbing Code. Assembly shall be installed with adequate drain and sufficient side clearance for testing and maintenance. The installation shall be made so that no part of the unit can be submerged or where relief valve discharge could cause damage.

#### **Specifications**

The Reduced Pressure Principle Backflow Preventer shall be UL® Classified, and supplied with full port, UL® LISTED OS&Y gate valves. The main body and access covers shall be cast bronze (ASTM B 584), the seat ring and all internal polymers shall be NSF® Listed Noryl™ and the seat disc elastomers shall be silicone. The first and second checks shall be accessible for maintenance without removing the relief valve or the entire device from the line. If installed indoors, the installation shall be supplied with an air gap adapter, adequate drain and integral monitor switch. The Reduced Pressure Principle Backflow Preventer shall be a ZURN WILKINS Model 975XLOSY.
